Notice is hereby given that the Board of Trustees of the Weber Basin Water Conservancy District will meet at the general offices of the District, 2837 E. Highway 193, Layton, Utah, on Thursday, May 23, 2024, at 9:00 a.m., for the purpose of hearing objections to assessments to be levied by the Board of Trustees of the Weber Basin Water Conservancy District in the year 2024 to pay the amount due to the Weber Basin Water Conservancy District for the year 2025 under Petitions and Orders by the Conservancy District thereon affecting lands in the following area in SUMMIT COUNTY, UTAH:

Attention is particularly called to the fact that the assessments as made do and will constitute a lien upon the lands to which the water covered thereby has been allotted, notwithstanding that the Petitioner may since the filing of this petition have sold some or all of the land for which water was petitioned and allotted. Accordingly, all persons now owning or interested in lands within the above described area should give heed hereto.
